

Wadle Bauunternehmung GmbH Rank 92 of 113

The relative strengths and weaknesses of Wadle Bauunternehmung GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wadle Bauunternehmung GmbH compared to the market average is the variable Work In Progress Contracted Construction In Progress, increasing the Economic Capital Ratio by 67% points. The greatest weakness of Wadle Bauunternehmung GmbH is the variable Earnings After Taxes, reducing the Economic Capital Ratio by 56% points.

The company's Economic Capital Ratio, given in the ranking table, is 157%, being 87% points below the market average of 243%.
