



The relative strengths and weaknesses of GP Con GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of GP Con GmbH compared to the market average is the variable Earnings After Taxes, increasing the Economic Capital Ratio by 128% points. The greatest weakness of GP Con GmbH is the variable Receivables From Affiliated Companies, reducing the Economic Capital Ratio by 248% points.

The company's Economic Capital Ratio, given in the ranking table, is 361%, being 117% points above the market average of 243%.
