The greatest strength of Hanova Gewerbe GmbH compared to the market average is the variable Profit And Loss Transfer Subsidiary Remainder, increasing the Economic Capital Ratio by 88% points. The greatest weakness of Hanova Gewerbe GmbH is the variable Earnings After Taxes, reducing the Economic Capital Ratio by 80% points.

The company's Economic Capital Ratio, given in the ranking table, is 265%, being 24% points above the market average of 242%.
