

## Knobel BAU GmbH Rank 25 of 108

The relative strengths and weaknesses of Knobel BAU GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Knobel BAU GmbH compared to the market average is the variable Earnings After Taxes, increasing the Economic Capital Ratio by 54% points. The greatest weakness of Knobel BAU GmbH is the variable Liabilities Remainder, reducing the Economic Capital Ratio by 25% points.

The company's Economic Capital Ratio, given in the ranking table, is 281%, being 26% points above the market average of 256%.
