

#### Schmeing Bau GmbH Rank 12 of 108

The relative strengths and weaknesses of Schmeing Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Schmeing Bau GmbH compared to the market average is the variable Earnings After Taxes, increasing the Economic Capital Ratio by 40% points. The greatest weakness of Schmeing Bau GmbH is the variable Cash In Hand Central Bank Balances Bank Balances And Cheques, reducing the Economic Capital Ratio by 55% points.

The company's Economic Capital Ratio, given in the ranking table, is 314%, being 59% points above the market average of 256%.
