

BMS Industriebau GmbH Rank 100 of 110

The relative strengths and weaknesses of BMS Industriebau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of BMS Industriebau GmbH compared to the market average is the variable Prepayments And Assets Under Construction, increasing the Economic Capital Ratio by 17% points. The greatest weakness of BMS Industriebau GmbH is the variable Liabilities Remainder, reducing the Economic Capital Ratio by 699% points.

The company's Economic Capital Ratio, given in the ranking table, is 105%, being 138% points below the market average of 243%.
