

#### Markgraf Familien GmbH Rank 54 of 110

The relative strengths and weaknesses of Markgraf Familien GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Markgraf Familien GmbH compared to the market average is the variable Stockholders Equity, increasing the Economic Capital Ratio by 48% points. The greatest weakness of Markgraf Familien GmbH is the variable Liabilities Remainder, reducing the Economic Capital Ratio by 45% points.

The company's Economic Capital Ratio, given in the ranking table, is 263%, being 20% points above the market average of 243%.
