

Schrobsdorff Bau Aktiengesellschaft Rank 79 of 110

The relative strengths and weaknesses of Schrobsdorff Bau Aktiengesellschaft are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Schrobsdorff Bau Aktiengesellschaft compared to the market average is the variable Earnings After Taxes, increasing the Economic Capital Ratio by 47% points. The greatest weakness of Schrobsdorff Bau Aktiengesellschaft is the variable Stockholders Equity, reducing the Economic Capital Ratio by 44% points.

The company's Economic Capital Ratio, given in the ranking table, is 214%, being 29% points below the market average of 243%.
