

#### Krüger Bau Bernau GmbH Rank 9 of 110

The relative strengths and weaknesses of Krüger Bau Bernau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Krüger Bau Bernau GmbH compared to the market average is the variable Liabilities Of Which Due Within1 Year, increasing the Economic Capital Ratio by 54% points. The greatest weakness of Krüger Bau Bernau GmbH is the variable Liabilities Remainder, reducing the Economic Capital Ratio by 61% points.

The company's Economic Capital Ratio, given in the ranking table, is 318%, being 75% points above the market average of 243%.
