

Peter Ahrens Bauunternehmen GmbH Rank 96 of 110

The relative strengths and weaknesses of Peter Ahrens Bauunternehmen GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Peter Ahrens Bauunternehmen GmbH compared to the market average is the variable Net Income Remainder, increasing the Economic Capital Ratio by 4,0% points. The greatest weakness of Peter Ahrens Bauunternehmen GmbH is the variable Stockholders Equity, reducing the Economic Capital Ratio by 104% points.

The company's Economic Capital Ratio, given in the ranking table, is 111%, being 132% points below the market average of 243%.
