


Cadolto Modulbau





Cadolto Modulbau GmbH Rank 41 of 110

The relative strengths and weaknesses of Cadolto Modulbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Cadolto Modulbau GmbH compared to the market average is the variable Stockholders Equity, increasing the Economic Capital Ratio by 51% points. The greatest weakness of Cadolto Modulbau GmbH is the variable Liabilities Remainder, reducing the Economic Capital Ratio by 46% points.

The company's Economic Capital Ratio, given in the ranking table, is 266%, being 23% points above the market average of 243%.
