



The relative strengths and weaknesses of HBG Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of HBG Bau GmbH compared to the market average is the variable Liabilities To Affiliated Companies, increasing the Economic Capital Ratio by 0,15% points. The greatest weakness of HBG Bau GmbH is the variable Liabilities Of Which Due Within 1 Year, reducing the Economic Capital Ratio by 669% points.

The company's Economic Capital Ratio, given in the ranking table, is 0,15%, being 248% points below the market average of 249%.
