


VSTR Rodewisch









VSTR AG Rodewisch Rank 19 of 116

The relative strengths and weaknesses of VSTR AG Rodewisch are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of VSTR AG Rodewisch compared to the market average is the variable Net Income, increasing the Economic Capital Ratio by 115% points. The greatest weakness of VSTR AG Rodewisch is the variable Liabilities Remainder, reducing the Economic Capital Ratio by 40% points.

The company's Economic Capital Ratio, given in the ranking table, is 307%, being 53% points above the market average of 254%.
