

Otto Mühlherr Baugesellschaft mbH Rank 64 of 116

The relative strengths and weaknesses of Otto Mühlherr Baugesellschaft mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Otto Mühlherr Baugesellschaft mbH compared to the market average is the variable Net Income Remainder, increasing the Economic Capital Ratio by 93% points. The greatest weakness of Otto Mühlherr Baugesellschaft mbH is the variable Earnings After Taxes, reducing the Economic Capital Ratio by 42% points.

The company's Economic Capital Ratio, given in the ranking table, is 262%, being 8,4% points above the market average of 254%.
