



The relative strengths and weaknesses of Bauunternehmung Peter Igl GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bauunternehmung Peter Igl GmbH compared to the market average is the variable Net Income, increasing the Economic Capital Ratio by 595% points. The greatest weakness of Bauunternehmung Peter Igl GmbH is the variable Cash In Hand Central Bank Balances Bank Balances And Cheques, reducing the Economic Capital Ratio by 1.040% points.

The company's Economic Capital Ratio, given in the ranking table, is 810%, being 557% points above the market average of 254%.
