

## Hans Holzner Baugesellschaft mbH Rank 39 of 116

The relative strengths and weaknesses of Hans Holzner Baugesellschaft mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Hans Holzner Baugesellschaft mbH compared to the market average is the variable Net Income Remainder, increasing the Economic Capital Ratio by 94% points. The greatest weakness of Hans Holzner Baugesellschaft mbH is the variable Earnings After Taxes, reducing the Economic Capital Ratio by 34% points.

The company's Economic Capital Ratio, given in the ranking table, is 273%, being 19% points above the market average of 254%.
