



The relative strengths and weaknesses of Markgraf Familien GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Markgraf Familien GmbH compared to the market average is the variable Cash In Hand Central Bank Balances Bank Balances And Cheques, increasing the Economic Capital Ratio by 41% points. The greatest weakness of Markgraf Familien GmbH is the variable Liabilities Remainder, reducing the Economic Capital Ratio by 77% points.

The company's Economic Capital Ratio, given in the ranking table, is 231%, being 26% points below the market average of 258%.
