The greatest strength of Fuchs Bau GmbH compared to the market average is the variable Liabilities Of Which Due Within1 Year, increasing the Economic Capital Ratio by 53% points. The greatest weakness of Fuchs Bau GmbH is the variable Liabilities Remainder, reducing the Economic Capital Ratio by 102% points.

The company's Economic Capital Ratio, given in the ranking table, is 281%, being 24% points above the market average of 258%.
