

The relative strengths and weaknesses of Otto Mühlherr Baugesellschaft mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Otto Mühlherr Baugesellschaft mbH compared to the market average is the variable Liabilities Of Which Due Within1 Year, increasing the Economic Capital Ratio by 52% points. The greatest weakness of Otto Mühlherr Baugesellschaft mbH is the variable Liabilities Remainder, reducing the Economic Capital Ratio by 99% points.

The company's Economic Capital Ratio, given in the ranking table, is 276%, being 19% points above the market average of 258%.
