

The greatest strength of Bauunternehmung Peter Igl GmbH compared to the market average is the variable Cash In Hand Central Bank Balances Bank Balances And Cheques, increasing the Economic Capital Ratio by 24% points. The greatest weakness of Bauunternehmung Peter Igl GmbH is the variable Net Income, reducing the Economic Capital Ratio by 91% points.

The company's Economic Capital Ratio, given in the ranking table, is 86%, being 172% points below the market average of 258%.
