

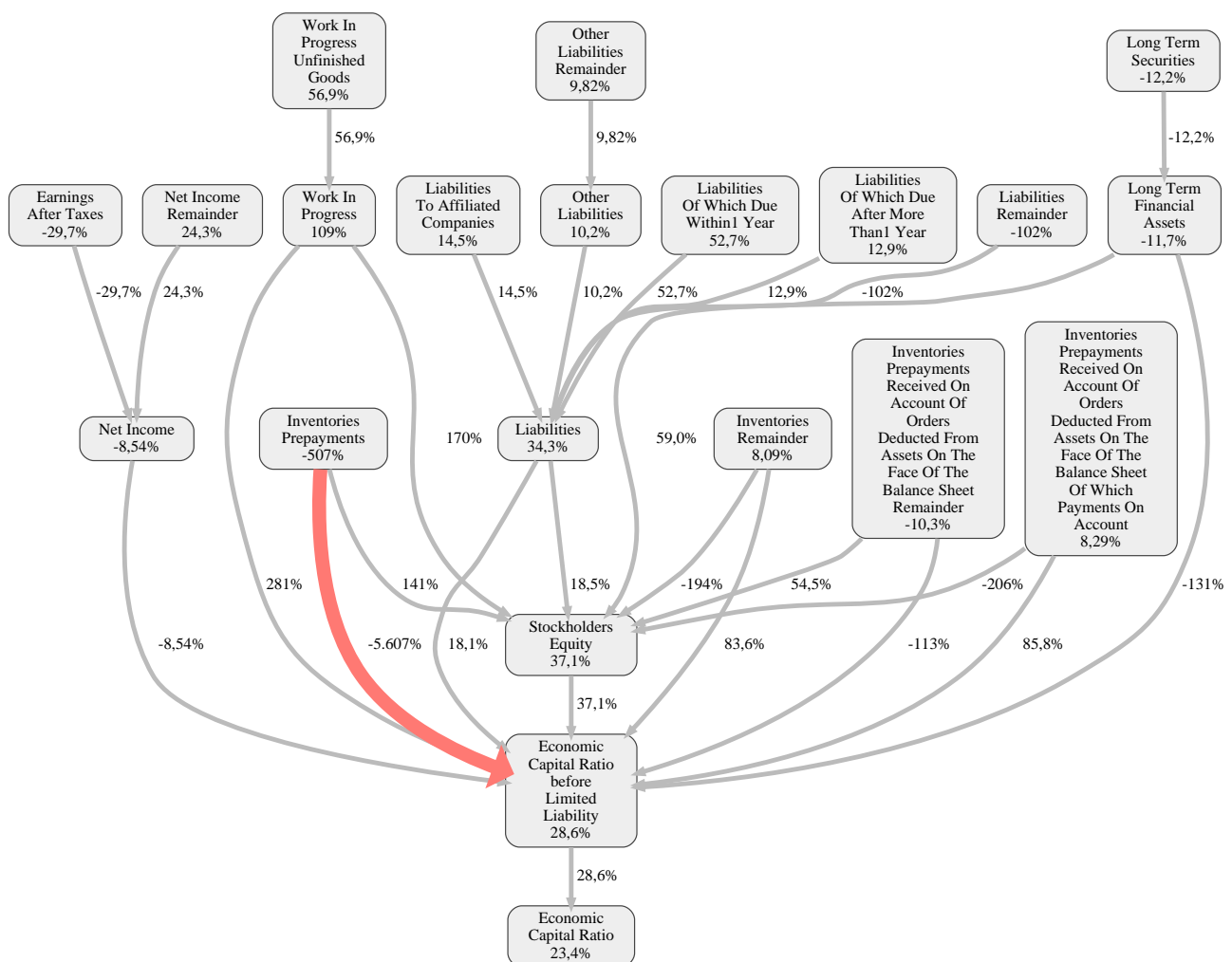

The relative strengths and weaknesses of Markgraf Familien GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Markgraf Familien GmbH Konzern compared to the market average is the variable Work In Progress, increasing the Economic Capital Ratio by 109% points. The greatest weakness of Markgraf Familien GmbH Konzern is the variable Inventories Prepayments, reducing the Economic Capital Ratio by 507% points.

The company's Economic Capital Ratio, given in the ranking table, is 281%, being 23% points above the market average of 258%.
