

The greatest strength of Ruben Schäfer Bauunternehmung GmbH compared to the market average is the variable Liabilities Remainder, increasing the Economic Capital Ratio by 140% points. The greatest weakness of Ruben Schäfer Bauunternehmung GmbH is the variable Liabilities Of Which Due Within1 Year, reducing the Economic Capital Ratio by 2.395% points.

The company's Economic Capital Ratio, given in the ranking table, is 251%, being 7,4% points above the market average of 243%.
