

#### Koska Bau GmbH Rank 93 of 113

The relative strengths and weaknesses of Koska Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Koska Bau GmbH compared to the market average is the variable Earnings After Taxes, increasing the Economic Capital Ratio by 81% points. The greatest weakness of Koska Bau GmbH is the variable Net Income Remainder, reducing the Economic Capital Ratio by 204% points.

The company's Economic Capital Ratio, given in the ranking table, is 145%, being 98% points below the market average of 243%.
