



The relative strengths and weaknesses of GP Con GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of GP Con GmbH compared to the market average is the variable Profit And Loss Transfer Subsidiary Remainder, increasing the Economic Capital Ratio by 83% points. The greatest weakness of GP Con GmbH is the variable Liabilities Remainder, reducing the Economic Capital Ratio by 49% points.

The company's Economic Capital Ratio, given in the ranking table, is 300%, being 58% points above the market average of 242%.
