


Monte Hochbau







Monte Hochbau GmbH Rank 91 of 109

The relative strengths and weaknesses of Monte Hochbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Monte Hochbau GmbH compared to the market average is the variable Inventories Remainder, increasing the Economic Capital Ratio by 62% points. The greatest weakness of Monte Hochbau GmbH is the variable Earnings After Taxes, reducing the Economic Capital Ratio by 91% points.

The company's Economic Capital Ratio, given in the ranking table, is 152%, being 90% points below the market average of 242%.
