



The relative strengths and weaknesses of Hanova Gewerbe GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Hanova Gewerbe GmbH compared to the market average is the variable Earnings After Taxes, increasing the Economic Capital Ratio by 113% points. The greatest weakness of Hanova Gewerbe GmbH is the variable Prepayments And Assets Under Construction, reducing the Economic Capital Ratio by 66% points.

The company's Economic Capital Ratio, given in the ranking table, is 305%, being 49% points above the market average of 256%.
