The greatest strength of Koska Bau GmbH compared to the market average is the variable Liabilities Of Which Due Within 1 Year, increasing the Economic Capital Ratio by 136% points. The greatest weakness of Koska Bau GmbH is the variable Earnings After Taxes, reducing the Economic Capital Ratio by 126% points.

The company's Economic Capital Ratio, given in the ranking table, is 157%, being 86% points below the market average of 243%.
