

#### Weberhaus GmbH Co KG Rank 14 of 110

The relative strengths and weaknesses of Weberhaus GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Weberhaus GmbH Co KG compared to the market average is the variable Liabilities Of Which Due Within1 Year, increasing the Economic Capital Ratio by 50% points. The greatest weakness of Weberhaus GmbH Co KG is the variable Liabilities Remainder, reducing the Economic Capital Ratio by 55% points.

The company's Economic Capital Ratio, given in the ranking table, is 298%, being 55% points above the market average of 243%.
