

#### Moser GmbH Co KG Rank 6 of 110

The relative strengths and weaknesses of Moser GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Moser GmbH Co KG compared to the market average is the variable Liabilities Of Which Due Within1 Year, increasing the Economic Capital Ratio by 342% points. The greatest weakness of Moser GmbH Co KG is the variable Inventories, reducing the Economic Capital Ratio by 151% points.

The company's Economic Capital Ratio, given in the ranking table, is 342%, being 99% points above the market average of 243%.
