

Markgraf Familien

The relative strengths and weaknesses of Markgraf Familien GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Markgraf Familien GmbH Konzern compared to the market average is the variable Work In Progress Unfinished Goods, increasing the Economic Capital Ratio by 168% points. The greatest weakness of Markgraf Familien GmbH Konzern is the variable Liabilities Of Which Due Within1 Year, reducing the Economic Capital Ratio by 326% points.

The company's Economic Capital Ratio, given in the ranking table, is 279%, being 36% points above the market average of 243%.
