



The relative strengths and weaknesses of Westdeutsche Rohbau Technik GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Westdeutsche Rohbau Technik GmbH compared to the market average is the variable Cash In Hand Central Bank Balances Bank Balances And Cheques, increasing the Economic Capital Ratio by 78% points. The greatest weakness of Westdeutsche Rohbau Technik GmbH is the variable Net Income, reducing the Economic Capital Ratio by 102% points.

The company's Economic Capital Ratio, given in the ranking table, is 187%, being 73% points below the market average of 260%.
