

VSTR AG Rodewisch Rank 78 of 115

The relative strengths and weaknesses of VSTR AG Rodewisch are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of VSTR AG Rodewisch compared to the market average is the variable Liabilities Of Which Due Within1 Year, increasing the Economic Capital Ratio by 28% points. The greatest weakness of VSTR AG Rodewisch is the variable Liabilities To Silent Partners, reducing the Economic Capital Ratio by 32% points.

The company's Economic Capital Ratio, given in the ranking table, is 244%, being 16% points below the market average of 260%.
