

Bauunternehmung Hermann GmbH Rank 38 of 115

The relative strengths and weaknesses of Bauunternehmung Hermann GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bauunternehmung Hermann GmbH compared to the market average is the variable Stockholders Equity, increasing the Economic Capital Ratio by 40% points. The greatest weakness of Bauunternehmung Hermann GmbH is the variable Liabilities Remainder, reducing the Economic Capital Ratio by 33% points.

The company's Economic Capital Ratio, given in the ranking table, is 271%, being 11% points above the market average of 260%.
