



The relative strengths and weaknesses of Peter Ahrens Bauunternehmen GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Peter Ahrens Bauunternehmen GmbH compared to the market average is the variable Stockholders Equity, increasing the Economic Capital Ratio by 40% points. The greatest weakness of Peter Ahrens Bauunternehmen GmbH is the variable Liabilities Of Which Due After More Than 1 Year, reducing the Economic Capital Ratio by 40% points.

The company's Economic Capital Ratio, given in the ranking table, is 285%, being 25% points above the market average of 260%.
