

Arning Bauunternehmung

The relative strengths and weaknesses of Arning Bauunternehmung GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Arning Bauunternehmung GmbH Konzern compared to the market average is the variable Earnings After Taxes, increasing the Economic Capital Ratio by 84% points. The greatest weakness of Arning Bauunternehmung GmbH Konzern is the variable Liabilities Remainder, reducing the Economic Capital Ratio by 43% points.

The company's Economic Capital Ratio, given in the ranking table, is 316%, being 56% points above the market average of 260%.
