

Goldbeck GmbH Konzern Rank 95 of 115

The relative strengths and weaknesses of Goldbeck GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Goldbeck GmbH Konzern compared to the market average is the variable Cash In Hand Central Bank Balances Bank Balances And Cheques, increasing the Economic Capital Ratio by 103% points. The greatest weakness of Goldbeck GmbH Konzern is the variable Net Income Remainder, reducing the Economic Capital Ratio by 199% points.

The company's Economic Capital Ratio, given in the ranking table, is 178%, being 82% points below the market average of 260%.
