

The greatest strength of Bickhardt Bau Aktiengesellschaft Konzern compared to the market average is the variable Receivables And Other Assets Remainder, increasing the Economic Capital Ratio by 37% points. The greatest weakness of Bickhardt Bau Aktiengesellschaft Konzern is the variable Liabilities Remainder, reducing the Economic Capital Ratio by 76% points.

The company's Economic Capital Ratio, given in the ranking table, is 170%, being 90% points below the market average of 260%.
