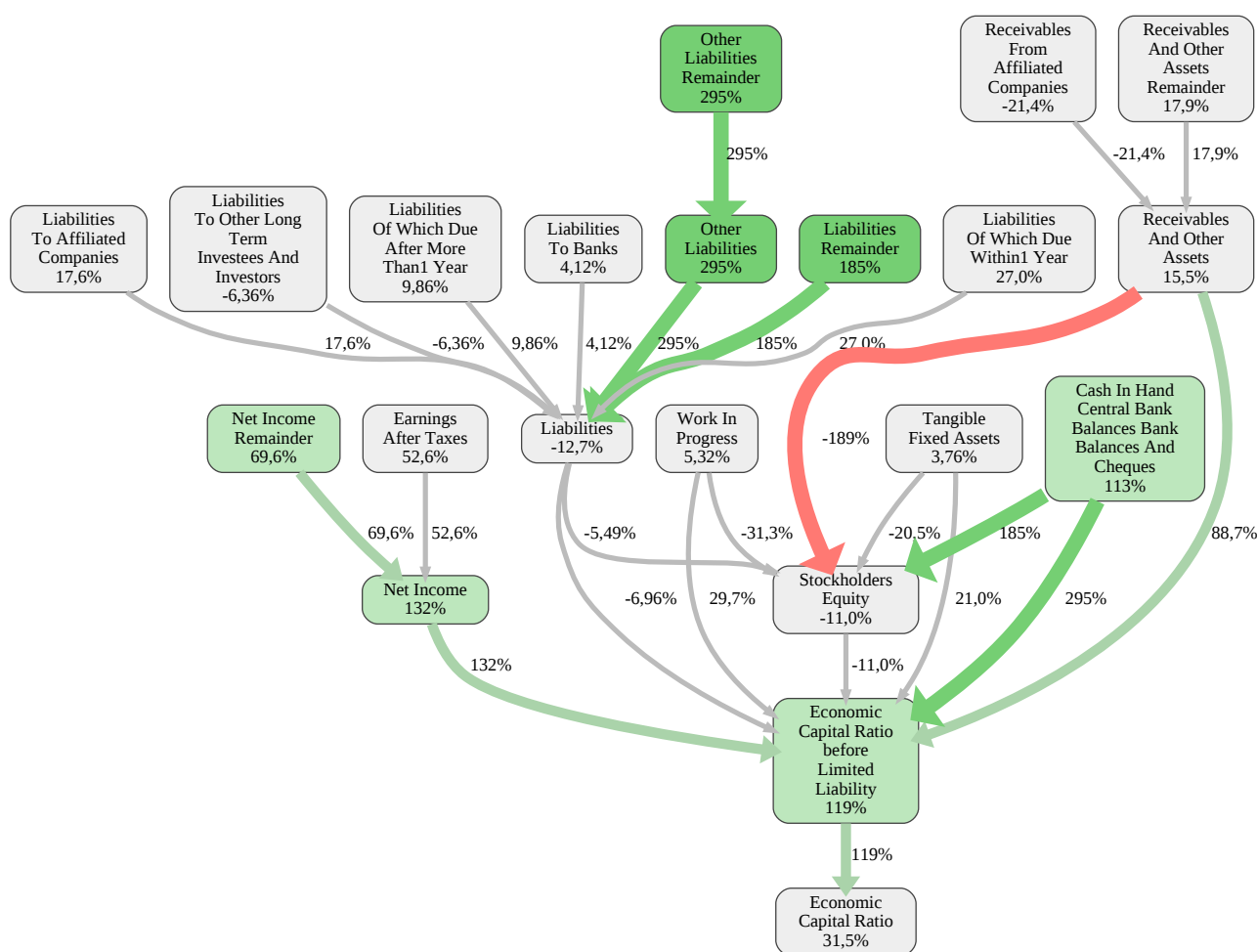




The relative strengths and weaknesses of Florack Bauunternehmung GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Florack Bauunternehmung GmbH compared to the market average is the variable Other Liabilities, increasing the Economic Capital Ratio by 295% points. The greatest weakness of Florack Bauunternehmung GmbH is the variable Receivables From Affiliated Companies, reducing the Economic Capital Ratio by 21% points.

The company's Economic Capital Ratio, given in the ranking table, is 295%, being 31% points above the market average of 264%.
