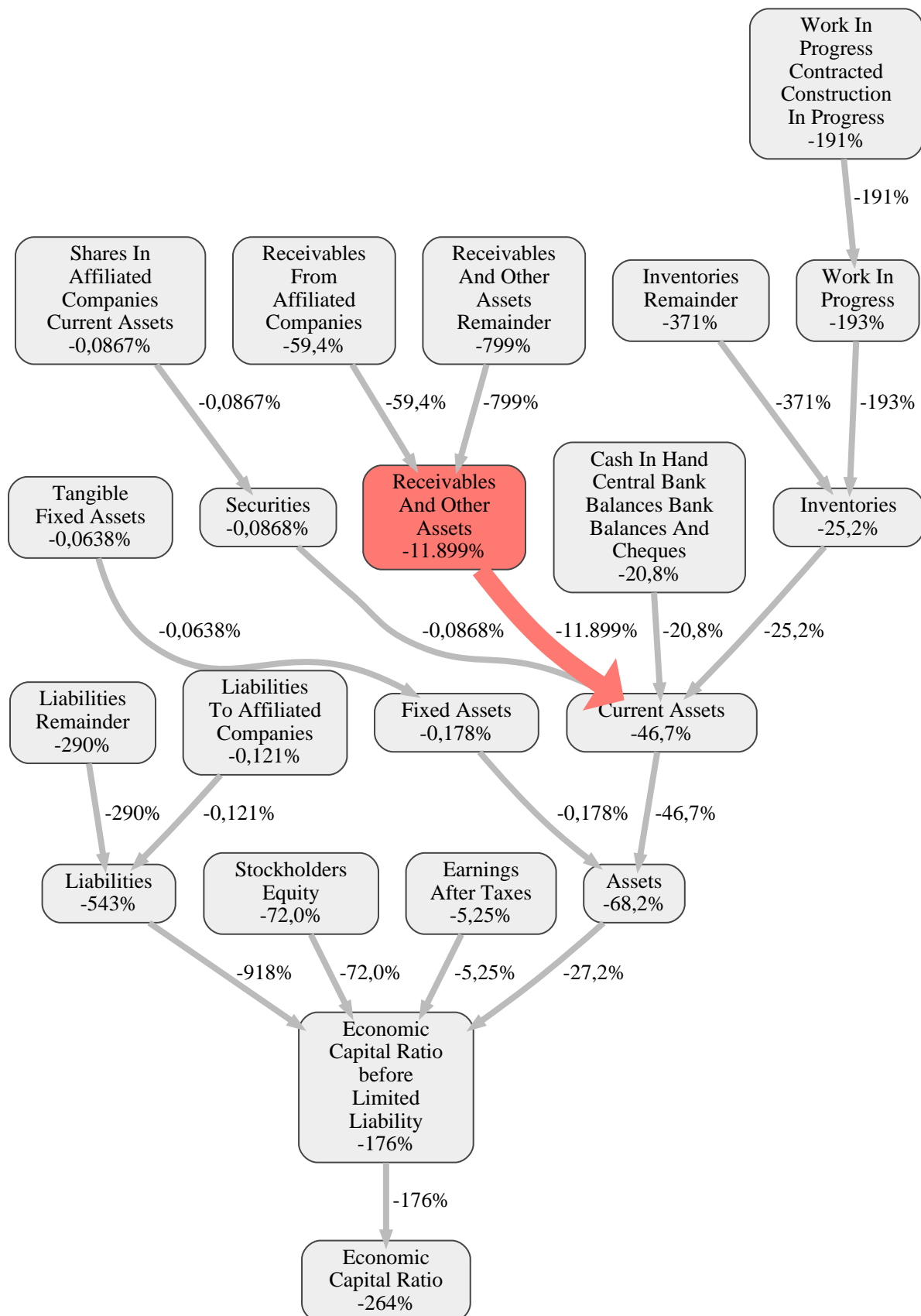

# Tell Bau



The relative strengths and weaknesses of Tell Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Tell Bau GmbH compared to the market average is the variable Net Income Remainder, increasing the Economic Capital Ratio by 0,00012% points. The greatest weakness of Tell Bau GmbH is the variable Receivables And Other Assets, reducing the Economic Capital Ratio by 11.899% points.

The company's Economic Capital Ratio, given in the ranking table, is 0,00011%, being 264% points below the market average of 264%.
