

Westdeutsche Rohbau Technik GmbH Rank 57 of 116

The relative strengths and weaknesses of Westdeutsche Rohbau Technik GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Westdeutsche Rohbau Technik GmbH compared to the market average is the variable Net Income Remainder, increasing the Economic Capital Ratio by 92% points. The greatest weakness of Westdeutsche Rohbau Technik GmbH is the variable Earnings After Taxes, reducing the Economic Capital Ratio by 45% points.

The company's Economic Capital Ratio, given in the ranking table, is 266%, being 2,9% points above the market average of 264%.
