

The relative strengths and weaknesses of Bateg GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bateg GmbH compared to the market average is the variable Net Income Remainder, increasing the Economic Capital Ratio by 86% points. The greatest weakness of Bateg GmbH is the variable Liabilities Remainder, reducing the Economic Capital Ratio by 31% points.

The company's Economic Capital Ratio, given in the ranking table, is 258%, being 5,9% points below the market average of 264%.
