The greatest strength of Markgraf Familien GmbH compared to the market average is the variable Cash In Hand Central Bank Balances Bank Balances And Cheques, increasing the Economic Capital Ratio by 41% points. The greatest weakness of Markgraf Familien GmbH is the variable Liabilities Remainder, reducing the Economic Capital Ratio by 77% points.

The company's Economic Capital Ratio, given in the ranking table, is 231%, being 27% points below the market average of 258%.
