

Ortwin Goldbeck Holding SE Rank 79 of 116

The relative strengths and weaknesses of Ortwin Goldbeck Holding SE are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Ortwin Goldbeck Holding SE compared to the market average is the variable Liabilities Of Which Due Within1 Year, increasing the Economic Capital Ratio by 48% points. The greatest weakness of Ortwin Goldbeck Holding SE is the variable Liabilities Remainder, reducing the Economic Capital Ratio by 80% points.

The company's Economic Capital Ratio, given in the ranking table, is 241%, being 17% points below the market average of 258%.
