The greatest strength of Baugesellschaft Walter Hellmich GmbH compared to the market average is the variable Liabilities Of Which Due Within1 Year, increasing the Economic Capital Ratio by 49% points. The greatest weakness of Baugesellschaft Walter Hellmich GmbH is the variable Liabilities Remainder, reducing the Economic Capital Ratio by 54% points.

The company's Economic Capital Ratio, given in the ranking table, is 251%, being 6,8% points below the market average of 258%.
