



The relative strengths and weaknesses of Krüger Bau Bernau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Krüger Bau Bernau GmbH compared to the market average is the variable Earnings After Taxes, increasing the Economic Capital Ratio by 116% points. The greatest weakness of Krüger Bau Bernau GmbH is the variable Cash In Hand Central Bank Balances Bank Balances And Cheques, reducing the Economic Capital Ratio by 204% points.

The company's Economic Capital Ratio, given in the ranking table, is 371%, being 113% points above the market average of 258%.
