

Arning Bauunternehmung GmbH Rank 88 of 113

The relative strengths and weaknesses of Arning Bauunternehmung GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Arning Bauunternehmung GmbH compared to the market average is the variable Other Taxes, increasing the Economic Capital Ratio by 90% points. The greatest weakness of Arning Bauunternehmung GmbH is the variable Liabilities To Banks, reducing the Economic Capital Ratio by 142% points.

The company's Economic Capital Ratio, given in the ranking table, is 194%, being 49% points below the market average of 243%.
