

The relative strengths and weaknesses of Moser GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Moser GmbH Co KG compared to the market average is the variable Work In Progress, increasing the Economic Capital Ratio by 220% points. The greatest weakness of Moser GmbH Co KG is the variable Current Assets, reducing the Economic Capital Ratio by 127% points.

The company's Economic Capital Ratio, given in the ranking table, is 427%, being 183% points above the market average of 243%.
