



The relative strengths and weaknesses of Ulrich Reitenberger Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Ulrich Reitenberger Bau GmbH compared to the market average is the variable Profit And Loss Transfer Subsidiary Remainder, increasing the Economic Capital Ratio by 83% points. The greatest weakness of Ulrich Reitenberger Bau GmbH is the variable Net Income Remainder, reducing the Economic Capital Ratio by 478% points.

The company's Economic Capital Ratio, given in the ranking table, is 294%, being 444% points below the market average of 737%.
