

The relative strengths and weaknesses of Bateg GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bateg GmbH compared to the market average is the variable Work In Progress Services In Progress, increasing the Economic Capital Ratio by 228% points. The greatest weakness of Bateg GmbH is the variable Work In Progress, reducing the Economic Capital Ratio by 2.970% points.

The company's Economic Capital Ratio, given in the ranking table, is 309%, being 429% points below the market average of 737%.
