

The relative strengths and weaknesses of Hans Holzner Baugesellschaft mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Hans Holzner Baugesellschaft mbH compared to the market average is the variable Profit And Loss Transfer Subsidiary Remainder, increasing the Economic Capital Ratio by 83% points. The greatest weakness of Hans Holzner Baugesellschaft mbH is the variable Net Income, reducing the Economic Capital Ratio by 422% points.

The company's Economic Capital Ratio, given in the ranking table, is 304%, being 434% points below the market average of 737%.
